We intend to construct a 507kW community-owned solar farm. Approximately 2112 solar panels will be used in the scheme. Each panel measures 1.66 by 0.99m, and the panels will be mounted in rows of two on steel frames. The frames will be installed in rows facing south, in order to maximise the sunlight received by the panels. Around 6m will be left between rows in order to prevent shading of solar panels in one row by the row in front. The land has recently been used for grazing sheep. We intend to continue grazing on the land between the solar panel frames.
